RELEASE AND INDEMNIFICATION AGREEMENT

THIS AGREEMENT made this ____ day of ____, 20____, between BATTLEFORDS SAILING CLUB, a body corporate, hereinafter called the "Club" and _____ hereinafter called the "Member".

WITNESSETH that in consideration of the Club permitting the undersigned to use its Boating facilities, clubhouse and services and in payment of the sum of One Dollar (\$1.00) by the Club to the Member and other good and valuable consideration (the receipt whereof is hereby acknowledged), the Member:

- (1) Waives, releases and forever discharges the Club, its servants, employees or agents of and from all manner of action, causes of action, accounts, claims or demands of whatsoever kind which against the Club, the Member ever had, now has or which the Member, his heirs, administrator, executor, successors or assigns will have, for or by reason of any cause, matter or thing, and howsoever arising and whether by negligence or otherwise and more particularly, but not so as to restrict the generality of the foregoing, from all claims, demands, manners of action, account or causes of action arising out of or in any way incidental to the launching, hauling, storage (wet or dry), mooring, maintenance or movement of any Boat owned by the Club, any member by the Club, its servants, employees or agents.
- (2) Agrees to indemnify the Club, its servants, employees or agents against any loss, damage or injury which they may suffer by reason of any acts or omissions of the member, and hold the Club, its servants, employees or agents harmless from all claims made upon them by reason of or arising out of the launching, hauling, storage (wet or dry), mooring, maintenance or movement of any Boat owned by the Member.
- (3) Agrees that the Club, its servants, employees or agents shall be under no responsibility whatsoever to the Member in respect of property of any kind or description of the Member, which is located on or about the lands, marinas or waters, leased by or surrounding the Club and including (without restricting the generality of the foregoing) any loss or damage sustained due to negligence or failure to fulfill any express or implied obligation to use care by the Club, its members, servants, employees or agents.
- (4) Agrees that the word Boat shall include its hull, machinery, fittings, hardware, rigging, sails, masts and appurtenances of every kind and description, its cradle, mooring and tender.

IMPORTANT NOTES:

- 1) No multi-day mooring of boats is allowed without executive approval. Boats that are kept in the water in front of the Club property must be placed on lifts.
- 2) Each Boat owner should contact his Boat insurer before entering into this Release and Indemnification Agreement, as the failure to do so may result in the insurer declaring the policy void.

BSC Member Information

Welcome to the Battlefords Sailing Club. In operation since 1964! As a new member, there are some things we want to inform you of so all are safe and the facility remains in good condition for members, renters, and guests to enjoy.

- Never assume: before venturing out on the water, check the weather forecast and pay attention to local conditions as things can change very quickly.
- Be prudent: if you have uncertainty about boating conditions and/or your skill level, stay on shore.
- Always wear a PFD with a whistle attached. Ensure the PFD fits (snug but not uncomfortable) and is in good condition. It is fitting properly if, when you pull up on the shoulder straps, the straps do not lift higher than your ears! Use PFDs marked BSC, in order to avoid using private gear. There is a good selection of adult and children's PFDs hanging on the downstairs wall. You might even consider purchasing a wetsuit suitable for boating.
- Tell someone that you are venturing out on the water and when you expect to be back.
- In case of emergency, please note the clubhouse does not have landline telephone service: check to see if your cell phone has a signal. The clubhouse is located on shore immediately to the east of the Regional Park, but cannot be accessed from the Regional Park parking area.
- There is a basic First Aid kit available on the kitchen counter.
- Respect club property and report any damage to equipment or facility maintenance issues so they can be quickly and properly addressed.
- Put all equipment away in its proper place after use. Ensure it is dry before storage.
- Feel free to bring family and friends as guests, but remember that you must be present at all times: you are responsible for your guests!
- Members should limit overusing guest privileges, but rather encourage others to become BSC members.
- Please note the BSC clubhouse is not a licensed facility unless a permit has been purchased for a special occasion.
- Sorry, but if possible, bag your garbage and take it home to be disposed of: it can be a long time between garbage pickups!
- After each use, **please make an entry in the "ship's log"** located on a table in the main area. Indicate who attended, equipment used, weather, etc. This is also a good place to report any maintenance issues you noticed. The ship's log is an excellent way to track member use and to assist with communication.
- Clubhouse keys are numbered and are BSC property. Please do not give out your key.
- Return your key if you at some point no longer wish to remain a member.
- If you lose your key, it is a \$20 charge to receive a new key.
- Be courteous to cabin owners. Please, if possible, try not to park where you might block their view of the lake.
- Cabin/day sailor sailboats require a boatlift. Mooring simply takes too much space and can make dinghy sailing and race organization difficult. Also, regularly check your boat to ensure that it is properly secured.

Thank you for your membership and welcome aboard!

We value your participation! The club very much relies on the honor system, and the responsibility and integrity of its members so that all participants can enjoy their lake experience. Members abusing privileges may have their membership suspended at the discretion of the BSC executive according to the BSC bylaws.

Before leaving the clubhouse, please make sure:

1. All lights/fans are turned off and toilets/urinals have been flushed.
2. Showers are clean and presentable.
3. The shut off valve for the outside tap is turned off.
4. Patio doors are locked (and wood pieces in place) and all other entry doors locked.
5. Make sure all windows are closed and locked.
6. Garage door is closed and securely latched- garage floor is swept.
7. Floor is vacuumed, kitchen is clean, and dishes are done.
8. BBQ is clean, propane tank is shut off, and cover is on.
9. The facility key ring **must** be placed back on its peg in the kitchen by the door.
10. The office door is locked.
11. Take time to walk around the building as a final check just in case something has been left outside!
